Louisiana State Firemen's Association April 24, 2018 Board Meeting Minutes

Board meeting called to order by Charlie Metcalf at 9:05 AM at Shaw Center of the Arts Conference Room, Baton Rouge, Louisiana. 4th District Rep. Brian Lindberg led us in the opening prayer. 2^{ce} Vice President Joe Thompson led us in the Pledge of Allegiance. Secretary Dwayne Thevis called roll call, the following members were present: SEE ATTACHED ROLL CALL SHEET.

President Charlie Metcalf introduced special guests in attendance. Donald Milligan, LSFA Past President, Chief Melvin Wheat, Denham Springs Fire Department, Melony Knab with Legal Shield Services, Ashley Rodrigue, Felicia Cooper with the OSFM.

Melony Knab spoke to the group and described services which her Legal Shield provides for organization similar to the LSFA. Legal Shield provides services such Standard Will Prep, Identity Theft Protection, Estate Planning, Financial Aid Preparation, and many more services. Costs of these services are minimal for members of the LSFA. Family Legal Plans start at \$23.95 monthly. For each member signing up with Legal Shield the LSFA would receive a small fee. Motion was made by Mike Labruzza for the LSFA to offer this benefit to our membership, Joe Thompson second the motion.

Secretary Dwayne Thevis submitted the minutes of the last board meeting to all board members via E-mail. Bob White, 8th District Rep. made a motion to accept the minutes as E-mailed, second by Melvin Kiff, 1th District Rep. Motion carried.

Treasurer Mike Labruzza submitted Treasurer's Report via E-mail to all board members. Motion to accept Treasurer's Report as E-mailed made by Danny Mayet, 3r District Rep., second by Joe Thompson 2[∞] Vice President. Motion carried.

2018 Exhibits Chairman Joe Thompson reported that he has met with all of the vendors at the LSU-FETI show and presented them with packets for the 2018 conference in Shreveport, and at this time he currently has 21 vendors.

OLD BUSINESS:

2018 Conference: Charlie Metcalf reported that he will be hosting "Hot Drills" July 17th and 18th. There will be a 50 person limit for Hot Drills. Hot Drills will be free of charge. Hot Drills will be open to anyone but LSFA members will have priority for participation. Classes will include "First Due Ventilation", "First Due Search", "Thermal Imaging Operations" and "Forcible Entry". Classes on July 20th and 21th will be "From the X-Box to the Box Alarm", "Don't Be That Guy" and "In Honor of The Charleston 9: A Study of Change Following Tragedy". Room reservations for Conference will open January 29, 2018. The first night stay will be billed nonrefundable if a reservation is made.

CFSI trip to Washington: Charlie Metcalf reported that members of the Louisiana Fire Service Delegation that attend CFSI in Washington, D.C. were well received and that a lot progress was made for the fire service in Louisiana. Board Members attending this year's congressional meeting where Brian Lindberg, 4th District Rep., Tim Crockett, 6th District Rep., and Charlie Metcalf, LSFA President. Tim Crockett expressed a great thanks to the membership for allowing him the opportunity to attend CFSI.

Redistricting of the LSFA was discussed and reported how it would affect voting rights within each district. Motion was made by Danny Mayet to provide a spread sheet of how redistricting would affect each district and present this to membership. And, also to bring it to a vote at the 114th Annual Business Meeting to be held in New Orleans, La. second was made by Brian Lindberg, motion carried.

NEW BUSINESS:

A new Alpha Software updated was requested by Dwayne Thevis at a cost of \$700.00, plus a request to hire Mrs. Elaine to help install new software and repair some issues that the secretary's office is currently experiencing. Mrs. Elaine fees are \$15.00 per hour. Danny Mayet made a motion to purchase the new software and acquire the services of Mrs. Elaine not to exceed \$1500.00. The funds for shall come from Past President registration, second by Bob White, motion carried.

Currently, an Eventbrite fee for this year's conference is \$250.00. Motion was made by Brian Lindberg to pay Eventbrite fees using conference funds, second by Danny Mayet, motion carried.

NVFC Membership Drive is doing very well, currently we have 380 members signed up.

Mike Labruzza explain the procedure in which he was going to us handle PayPal funds coming in for membership dues, conference registration and vendor registration. The board was in approval of the procedure for handling monies for each event.

The contract that we currently have with California Casualty will expire on June 1, 2018. Motion was made by Brian Lindberg for President Charlie Metcalf to sign the new contract, second by Bob White, motion carried.

The National Walk of Honor Foundation contacted President Charlie Metcalf about a current fund raising event that they would like the LSFA to help them with. Prior to 1981 there are currently no bricks for any LODD's in country. Bricks are available for \$100.00 each. Louisiana currently has 42 firefighters that are not recognized with a brick at the memorial. The board advised President Metcalf to acquire a list of these names and the departments they belonged to. It was suggested that maybe the departments would like to purchase the brick for their respective firefighter. The cost to the Louisiana Fire Service would \$4200.00.

A dues increase from \$6.00 to \$10.00 for membership into the LSFA was discussed. After a lengthy discussion President Charlie Metcalf appointed a Planning and Finance Committee to study the

issue and devise a comprehensive plan. Committee members are as follows: Charlie Metcalf, Danny Mayet, Brian Lindberg, Tim Crockett, Melvin Kiff and Bob White.

After much discussion on S.B. 198 a motion was made by Brian Lindberg for the LSFA to oppose the bill as written, and move towards a study of resolution to remedy the issue.

Danny Mayet reported that he has been in negations with the Crown Plaza in Baton Rouge, La. for the 2021 Conference.
